We also continued with our Community Pantry facility which was very kindly facilitated and supported mostly by Councillor Pat Partington's family who operate a similar facility in the Manchester area but on a much grander scale and are called The Bread and Butter Thing.

We shall continue our facility under a different style in the forthcoming months, and hopefully once again be in a position to deliver a free Christmas hamper to deserving causes in our village.
